Dear Friends and Family in our Community

**We need around £36,000* to fund the terrace, the ramp and
the structure for the office and accessible entrance.**

We are so thankful to so many of you who supported our fundraising appeal in 2021. Thank you again. It is incredible that we have raised all the funds for the new community annexe. The Lord has moved mountains to enable this. By acting in faith it is coming to fruition. We praise and Thank God for answered prayer

We are now looking to complete the second phase of the project. Inflation and unforeseen building regulations have increased the expected cost.

What do we need?

Today we still need £36,000* to build the entrance/office building and terrace area.

To fit out the office and entrance will need an extra £50,000. We can raise this over time.

We would also like to raise £25,000 to fund solar PV panels to help the environment.

*These costings leave a £19,000 contingency, which if unused can go towards the fit out costs.

Why are we doing this now?

Trustees have decided to proceed to avoid the risk that inflation makes it unaffordable.

What are we asking?

We are asking for final, one-off pledges and gifts to enable us to fund these works now. We do not need the cash immediately, but will need the £36,000 by April 2024.

We still have grant applications outstanding and savings to find, but we need final pledges in place to enable decisions to be made now.

A pledge is a commitment to give money now or in the future when needed.

Can I leave a gift in my will?

Yes, a legacy can be left in your will, however we cannot rely on these for near term funding.

Please pray and consider if you can help this project to be completed in full next year.
